

BROADVIEW FIRE DEPARTMENT OPEN HOUSE

To help kick off the 2005 National Fire Prevention week, the Broadview Fire Department will be hosting an Open House on Saturday, October 8, from noon to 4:00 p.m.

We plan on having a fun filled, action packed day, and invite everyone to join us. We will have live demonstrations, such as vehicle extrication with our rescue squad, Children's Smoke House and a live burn scenario. On hand will be your firefighters, and equipment. We will also be providing blood pressure checks, proper home fire escape plans, and mock 911 emergency calling. Barring any bad weather or emergency calls Loyola Lifestar helicopter will be landing at the firehouse.

There will be a special appearance from Illinois State Trooper Doug Whitmore. Trooper Whitmore will demonstrate a simulated vehicle roll over, encouraging the importance of wearing seat belts. In attendance will be Officer Mitch Kushner and his arson dog Raider. The Ronald McDonald tour bus will be on hand to give asthma and vision exams.

All the children that attend Lindop, Roosevelt and Komareck Schools and reside in Broadview are eligible to enter a drawing to win a ride on the fire engine. Three children will be selected to choose a day of their choice for their ride to and from school.



Driver's License renewal can be made up to a year in advance. You do not have to be a Broadview resident or a Senior to take advantage of the services.

Employees from the businesses can use the facility services. You do not have to be a Broadview resident.

ILLINOIS IDENTIFICATION CARD/DRIVERS LICENSE REQUIREMENTS:

To receive an Illinois Identification Card or Illinois Drivers License you must provide a minimum of three acceptable forms of identification. You must do so to prove name, date of birth, Illinois residency, Social Security Number and signature for comparison. One of these forms should be a certified birth certificate.

NOTE:

Your signature on any of the following official documents will be used for comparison to the signature on the driver's license or the I.D. card application. Driver services facility personnel will make the final decision on whether identification is acceptable. Additional documents, not listed here, may be acceptable upon review by facility personnel. Facility personnel also have the right to require additional proof of identity.
